



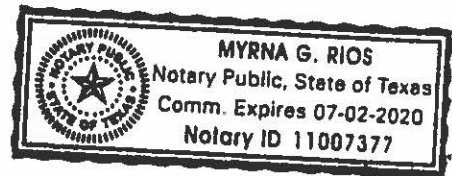

ALLEGATION

In June 2016, the Office of the City Auditor received an allegation that Police Monitor Margo Frasier misused City resources for secondary employment as an expert witness in various court cases.

BACKGROUND

The Office of the Police Monitor is a "vehicle for people to voice and file complaints against APD officers." The department "assesses complaints, monitors Internal Affairs investigations, and makes recommendations on policy, procedures, and disciplines." Margo Frasier was the Police Monitor and Director of the department from January 2011 until February 2017.

INVESTIGATION RESULTS

We found evidence indicating that Margo Frasier misused City resources, including her City computer, for purposes related to her secondary employment.

Note: We are aware of the two year statute of limitation required by the Ethics Review Commission and have provided evidence for that specific timeframe. Additionally, we have included evidence from outside the two year limit for further context.

City Code 2-7-62(J) requires that no City official or employee shall use City facilities, personnel, equipment or supplies for private purpose, except to the extent such are lawfully available to the public.

We found evidence that Frasier is a consultant in the field of criminal justice, and provides expert witness services in addition to her City employment. When interviewed, Frasier confirmed that she has secondary employment as a consultant and estimated that she spends 20 hours, sometimes more, a week on her secondary employment. She stated that her former managers were aware of this but that she did not disclose this to her supervisor, Elaine Hart, or Ray Arellano following her previous supervisor's departure. Frasier disclosed her secondary employment in her statement of financial information, as required by City Code. [Exhibit C]

Documents on the City computer related to the secondary employment

On Frasier's City computer, we found seven documents that appeared to be related to her secondary employment as an expert witness and criminal justice consultant. These included:

- two documents related to one of her clients (both from February 2016) [Exhibit B],

The following documents appear to be outside the statute of limitations:

- a legal brief (from January 2015) [Exhibit B],
- two written affidavits (one from April 2014 and from February 2015), and
- two expert reports (both from February 2014) [Exhibit B].

In the written affidavits and expert reports she declares herself to be a "self-employed criminal justice consultant" and expert; two of them included her signature. Frasier also admitted to editing documents related to her secondary employment on her City computer.

Use of City computer for browsing internet

Additionally, from February to July 2016, we found over 200 hits to websites that appear to be related to the secondary employment, including:

- 57 to her personal email account, which she stated she uses for secondary employment [Exhibit D].
- 97 hits that appear to be related to a client listed in her statement of financial information [Exhibit E].
- 58 hits that appear to be related to another client listed on the financial disclosure [Exhibit F].

We also noted a significant amount of leisure browsing, but did not conduct detailed analysis similar to the secondary employment browsing history.

Frasier admitted to checking her personal email account, which she uses for her secondary employment, during City time on her City computer.

City time

A staff member from the Office of the Police Monitor stated that they witnessed Frasier doing work related to her secondary employment while on City time. This staff member recalled Frasier taking a call during a meeting at work and reviewing legal documents while on a work-related conference. Frasier admitted that she took calls during City time from people seeking her services as a consultant, but that she would tell callers that she would call them back.

City email

We also reviewed Frasier's City email and found several emails that suggest people have reached out to Frasier to request her assistance as a consultant. However, in almost all examples she appears to have referred these individuals to her personal email, which we have described above [Exhibit G]. We did not find evidence indicating that Frasier solicited secondary employment business from her City of Austin email address.

Frasier's use of City resources related to her outside employment appears to constitute violations of the following criteria:

- City Code: Standard of Conduct §2-7-62 (J)

METHODOLOGY

To accomplish our objective, we performed the following steps:

- reviewed applicable City Code and policy;
- conducted background research;
- conducted interviews with City employees;
- analyzed subject's City email and computer using keywords provided in the allegation; and
- interviewed the subject.

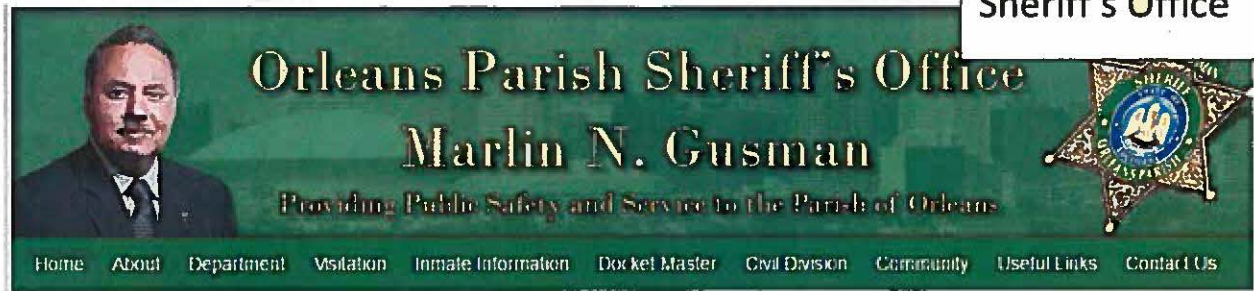

Negotiations seek to avoid total federal takeover of Orleans jail from Gusman, sources say

Parties pushing for a federal takeover of the Orleans Parish jail are working with Sheriff Marlin Gusman this week to reach an alternative resolution, according to three sources familiar with the negotiations. Such a deal could allow Gusman to retain at least some of his authority over the facility, the sources say.

An agreement could halt a federal court hearing about conditions at the jail that is scheduled to resume Friday, likely sparing Gusman from testifying about conditions at the troubled jail.

U.S. District Judge Lance Africk, who would have to approve any agreement, has twice postponed the restart of the hearing this week, both times without a public reason stated. It's currently scheduled to resume Friday. If an agreement has been reached and approved by then, the terms could possibly be revealed in court that day. It's possible that date, too, could be pushed back, the sources indicated.



'No clue': Expert says of Gusman's ability to run jail

Jail monitors testify

Lead monitor Susan McCampbell, an expert in the corrections field, testified the first day of the hearing that Gusman's administration seemed to have "no clue" how to run a jail. She and monitor Margo Frasier, a former sheriff in Austin, Texas, testified about increased instances of violence at the jail -- even after moving into a new \$145 million facility in September -- and expressed concern about what they believed to be underreporting of violence.

Brownfield officer cleared in federal court on charge of assaulting suspect

Sgt. Joshua Coronado cleared Tuesday afternoon, Feb. 4, in excessive-force civil lawsuit by Zackary Kegan Cruz.

A Brownfield police officer was cleared Tuesday, Feb. 4, of an accusation that he assaulted a suspect he was attempting to take into custody two-and-a-half years ago.

Sgt. Joshua Coronado acted reasonably within his duties when he arrested 23-year-old Zackary Kegan Cruz on Aug. 6, 2011, according to a ruling by a federal jury after less than 20 minutes of deliberation.

Coronado faced a civil trial in U.S. District Court in Lubbock on a claim that he kicked Cruz multiple times in the head while he was lying handcuffed near his patrol vehicle. A lawsuit filed in July 2012 sought damages in an unspecified amount.

"This is a case of excessive force," David Martinez, his attorney, told the three-man, three-woman jury in his closing arguments. "There's no reason after a person is subdued and handcuffed to be subjected to this kind of treatment."

Neither Coronado nor Cruz displayed emotion as U.S. District Judge Sam Cummings read the verdict.

Matt Matzner, Coronado's attorney, told A-J Media he and his client were pleased with the ruling, but not surprised.

Coronado's defense rejected the claim that he caused those wounds, instead attributing them to Cruz striking a fence when he fled from police custody.

Margo Frasier, an Austin-based consultant on law-enforcement issues, testified for the defense after reviewing the surveillance footage and documents related to the case. She agreed Cruz was likely injured when he hit the fence and then fell when officers forced him to the ground, which she said is standard procedure when a suspect disobeys commands to surrender.

Negotiations seek to avoid total federal takeover of Orleans jail from Gusman, sources say

Parties pushing for a federal takeover of the Orleans Parish jail are working with Sheriff Marlin Gusman this week to reach an alternative resolution, according to three sources familiar with the negotiations. Such a deal could allow Gusman to retain at least some of his authority over the facility, the sources say.

An agreement could halt a federal court hearing about conditions at the jail that is scheduled to resume Friday, likely sparing Gusman from testifying about conditions at the troubled jail.

U.S. District Judge Lance Africk, who would have to approve any agreement, has twice postponed the restart of the hearing this week, both times without a public reason stated. It's currently scheduled to resume Friday. If an agreement has been reached and approved by then, the terms could possibly be revealed in court that day. It's possible that date, too, could be pushed back, the sources indicated.

A statement released by OPSO Wednesday does not confirm or deny negotiations. It says the agency "remains steadfast" in its opposition to a federal takeover but has "always been willing to and remain(s) willing" to work with the Justice Department, plaintiffs and City "to move forward in the best interests" of OPSO employees, inmates and the citizens of New Orleans. The statement also says the office intends to prove at the hearing OPSO has made progress "even in the face of adversity."

Jail monitors testify

Lead monitor Susan McCampbell, an expert in the corrections field, testified the first day of the hearing that Gusman's administration seemed to have "no clue" how to run a jail. She and monitor Margo Frasier, a former sheriff in Austin, Texas, testified about increased instances of violence at the jail -- even after moving into a new \$145 million facility in September -- and expressed concern about what they believed to be underreporting of violence.

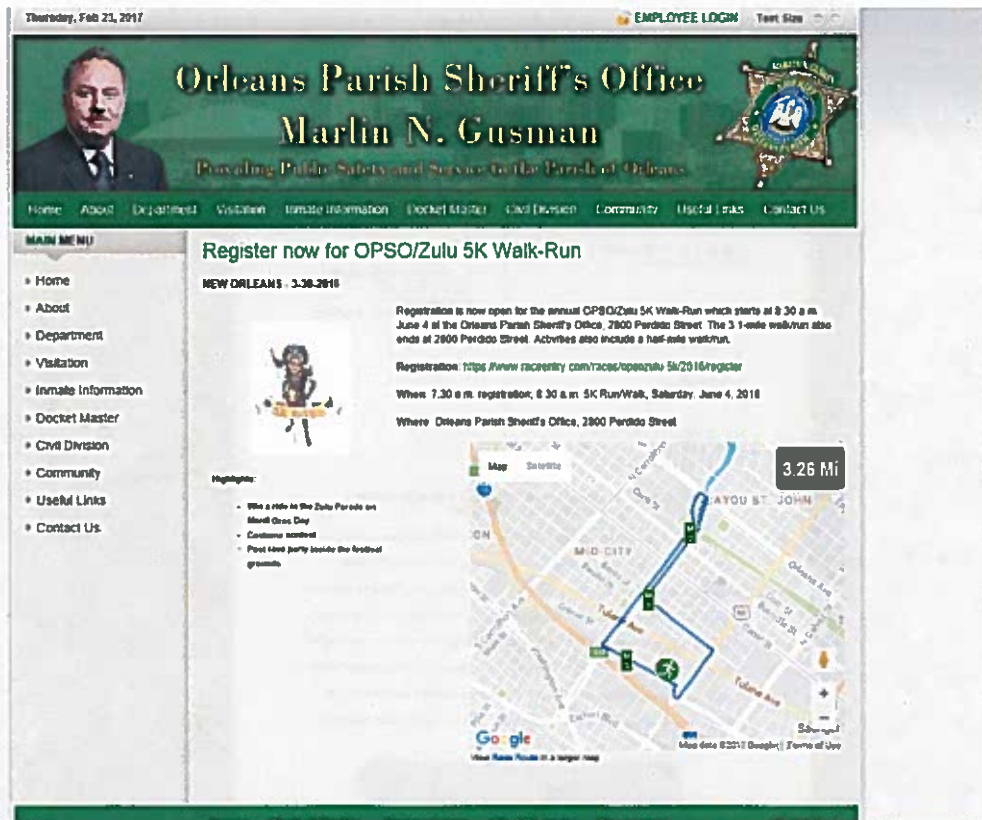

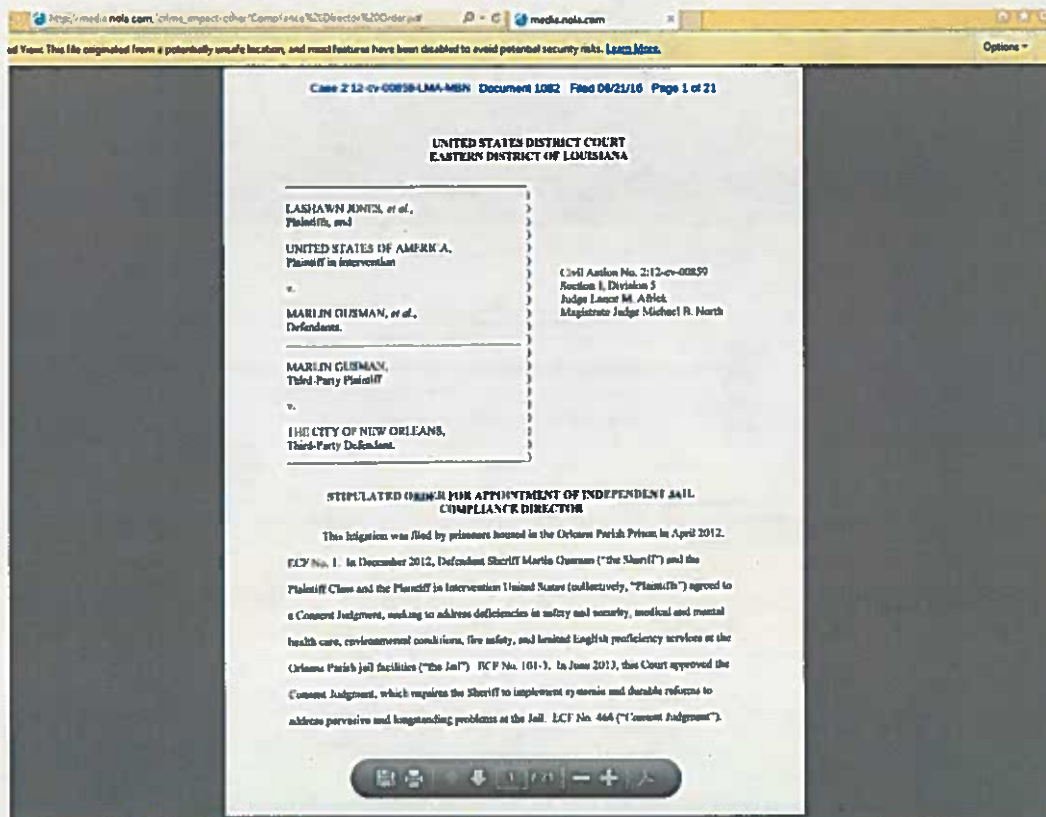

"Mismanagement at the Civil Rights Division of the Department of Justice"

Chairman Goodlatte, Ranking Member Conyers and Members of the Judiciary Committee:

Thank you for inviting me to testify before you today regarding my recent experience with the Civil Rights Division of the Department of Justice, under the management (or mismanagement) of Attorney General Eric Holder and Assistant Attorney General Thomas E. Perez.

My name is Horatio Mihet, and I am Senior Litigation Counsel at Liberty Counsel, a nonprofit litigation, education, and policy organization dedicated to protecting our First Freedoms. I grew up in communist Romania, where I watched my dad and others like him constantly harassed and jailed by the government because of what they said and did in leading the Underground Church. Therefore, I know what happens when the very government agency charged with safeguarding the civil rights of its citizens becomes complicit in violating those rights.

He has consulted for the US Department of Justice, US Marshals Service conducting detention center operations assessments.

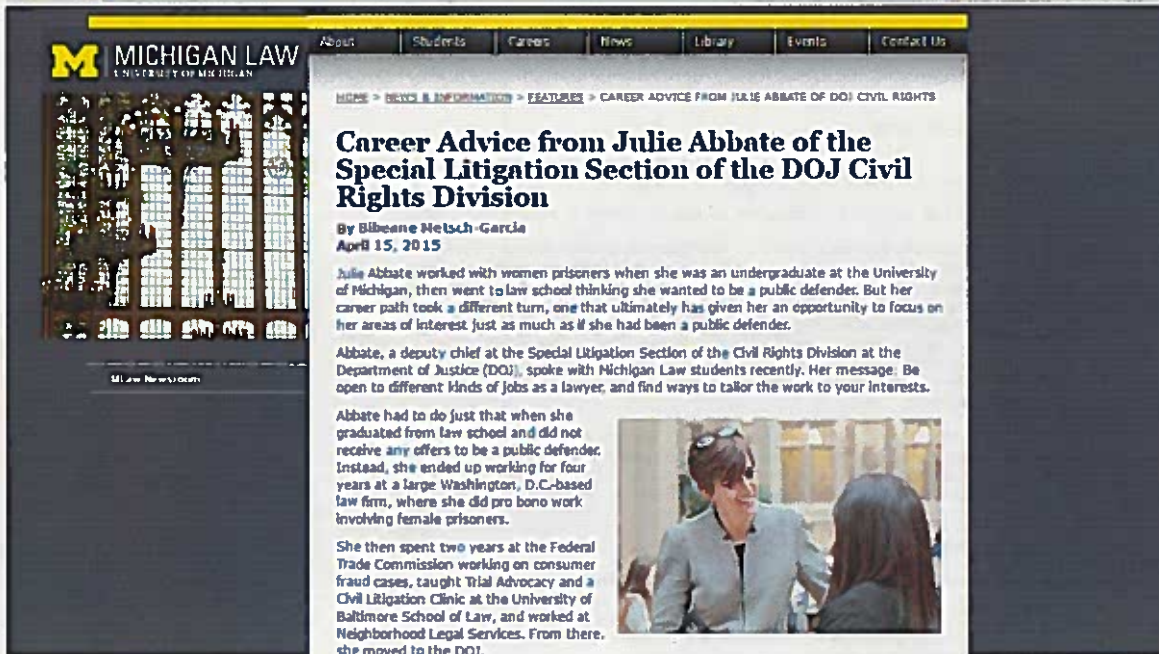

My name is Bennett Stein – I am Special Assistant to the NYC Board of Correction. As you may know, the Board of Correction is a nine person non-judicial oversight board which regulates, monitors, and inspects the correctional facilities of the City. Our Executive Director, Martha King, received your contact information, as a person important for us to connect with, from Brian Buchner at NACOLE.

I am writing with the Board's request to speak with you. The Board voted recently to begin the process of writing local rules regarding various issues, including Classification of Prisoners, Recreation, Visiting, Packages, Enhanced Supervision Housing, and Punitive Segregation. The proposed rule is posted [here](#), on our website. This process includes thirty days of deliberation prior to a public hearing and, in this case, additional deliberation after the public hearing and prior to a vote on a final rule. As it considers the proposed rule, the Board sets up small group meetings with experts and interested parties to inform their decisions.
