

Subdivision Plan Review Fees

Effective: October 1, 2018 Updated: April 10, 2019

A completeness check is required on all site plan and subdivision applications. Once your completeness check is approved, call the intake staff to schedule an appointment to submit your application at one of the following number:

Contractors must contact the City Of Austin - Site and Subdivision Inspection Division to submit required documentation, pay construction inspection fees, and schedule the required Subdivision pre-construction meeting. This meeting must be held prior to any construction activities in the R.O.W. or public easements.
