Development Services Surcharge (Assessed on all Development Services Department – DSD – Fees)	4% of DSD fees
Protected Street Fees	This fee is calculated in square yards based upon the actual size of the subgrade excavation within the paved area plus 18” on each side. The square yardage is then multiplied by the Street Unit Cost, which is calculated based upon age and condition of the pavement.
